Budget

State Imposed Sales Tax Holiday

Mr. Spykerman stated that the District had the option to participate or not participate in the sales tax holiday for back-to-school supplies. Mr. Butz noted that the City participated in the sales tax holiday, but that Phelps County did not. The Board briefly discussed the matter, but took no action.

Comments by Board, Advisors and Public

Mr. Spykerman described a proposed schedule for the approval and issuance of the District's bonds. The Board discussed the bond issue.

Director Magdits and Mr. Butz initiated discussion of potential administrative services that the District may require.
